

CHILD LEGAL WAIVER

Release, Waiver and Assumption of Risk Agreement. Parent Acknowledgement, Release, and Agreement to Indemnify

I, _____ being the parent/guardian of _____ (herein called my child), for good and valuable consideration, the receipts whereof being hereby acknowledged, do hereby agree and acknowledge:

1. That I/we have read and understand fully the attached RELEASE, WAIVER AND ASSUMPTION OF RISK agreement;
2. That I/we have explained to my/our child the consequences of signing the said RELEASE, WAIVER AND ASSUMPTION OF RISK agreement;
3. That the said RELEASE, WAIVER AND ASSUMPTION OF RISK agreement is on the whole beneficial to my/our child;
4. that I/we do hereby release "Maverix Snow Camp" (herein called Maverix), their members, officers, directors, coaches, employees, sponsors, independent contractors and agents from all liability, and do hereby waive as against Maverix, their members, officers, directors, coaches, employees, sponsors, independent contractors and agents, all recourses, proceedings, claims and causes of actions of any kind whatsoever, in respect of damages I/we might suffer as a consequence of my/our child sustaining personal injury, death or property loss while participating in the snowboarding camp and related activities referred to in the above RELEASE, WAIVER AND ASSUMPTION OF RISK agreement, notwithstanding that such injury, death or loss, may have been caused solely or partly by the negligence of Maverix, or any of their members, officers, directors, coaches, employees, sponsors, independent contractors or agents;
5. that I/we acknowledge and understand that my/our child may be provided by Maverix with transportation to and from the snowboarding camp and related activities and that my/our child will be participating in various activities, including but not limited to those outlined above, some or all of which are inherently dangerous. My our/child voluntarily agrees to participate in these activities and accept the transportation provided to them in order to so participate.
6. that I/we do hereby agree to indemnify and hold harmless Maverix, their members, officers, directors, coaches, employees, sponsors, independent contractors and agents from any and all claims, demands, causes of action of any kind whatsoever including those involving negligence on the part of Maverix or any of their members, officers, directors, coaches, employees, sponsors, independent contractors or agents, that may be made or initiated by, or on behalf of my/our child, arising out of or connected with my/our child's preparation for or participation in any of the snowboard camp and related activities referred to in the above RELEASE, WAIVER AND ASSUMPTION OF RISK agreement.

VIDEO & PHOTO WAIVER

You hereby release “Maverix Snow Camp” and their members, officers, directors, coaches, employees, sponsors, independent contractors and agents from and against any and all claims, demands, actions, causes of actions, suits, costs, expenses, liabilities, and damages whatsoever that you may hereafter have against “Maverix Snow Camp” in connection with the Property.

This agreement shall not obligate “Maverix Snow Camp” and their members, officers, directors, coaches, employees, sponsors, independent contractors and agents to use the Property or to use any of the rights granted hereunder, or to prepare, produce, exhibit, distribute or exploit the Property. “Maverix Snow Camp” and their members, officers, directors, coaches, employees, sponsors, independent contractors and agents shall have the right to assign its rights hereunder, without your consent, in whole or in part, to any person, firm or corporation.
